### ACADEMIES OF THE FINE ARTS

#### **GENERAL REGULATIONS**

- Art. 1 Peano Foundation International Sculpture Competition is open to Italian and international students of the Academies of the Fine Arts. Participation is free.
- Art. 2 The theme of the 2017 edition of the competition is "The Swan (twenty years later) – A sculpture for Boves Square in Cuneo, the square of art and love", theme which can be explored through the various languages of sculpture, in order to submit projects appropriate for outdoor exhibition.
- Art. 3 The application form for the competition must be e-mailed to: segreteria@ fondazionepeano.it before June 9th, 2017.
- Art. 4 The below listed items must be sent to: Fondazione Peano Corso Francia, 47 - 12100 Cuneo, Italy before July 21st, 2017 otherwise the student will be excluded from the competition:
  - n° 1 three-dimensional model created with a freestyle technique;
- n° 1 CD containing: n° 2 digital colour photographs of the model in high definition, jpg of tiff format; n° 1 written description of the project in pdf format including the title of the artwork, the name of the Academy, the name of the tutor and the personal details of the creator of the model (name, surname, postal address, telephone number and e-mail address), as well as the information regarding the conception of the artwork and information regarding its realisation and actual dimensions.
- Students are invited to note that the final artwork must have its own stand, which must be simply laid down on the ground, anchoring of any kind are not allowed. The weight should not exceed 700kg/sq.m. The structure, should develop in height, will have to guarantee a good tipping stability, which may be caused by weather or vandalism, including climbing. The base can cover a maximum area of 3x2m. The above listed items must be sent to: Fondazione Peano – Corso Francia, 47 – 12100 Cuneo, Italy.
- Art. 5 The artwork model will be shipped at the participant's expense. Any damaged models will neither be judged nor displayed.
- Art. 6 Participation in the competition automatically gives to Peano Foundation the authorisation to display and/or publish the artwork. Peano Foundation's only obligation is to cite the artists' names.
  - All the artwork models admitted to the Competition by the jury panel will be published in the catalogue and displayed in the exhibition. Students will be informed of the eventual exclusion to the Competition immediately after the meeting of the jury panel at the beginning of September.

- Art. 7 The winning artwork models will remain property of Peano Foundation, which reserves the right to display them at its main office or during exhibitions.
- Art. 8 Non prize-winning models which are not collected before November 30<sup>th</sup> 2017 will remain property of Peano Foundation, which reserves the right to display them. Those who cannot pick up their model in person or by delegate, can agree with Peano Foundation a pick up by courier whose costs must be covered by the participant. Peano Foundation packages the model to the best of its ability, reusing -if available and undamaged-the original packaging but it is not liable for any damage that might occur to the models during transportation.
- Art. 9 The jury panel will award study grants to the artists of the three winning artworks. The prizes are the following:

1st place: 3,000 Euro 2<sup>nd</sup> place: 1,000 Euro 3<sup>rd</sup> place: 500 Euro

The artwork winning the competition must be realized by the artist within ten months from winning the competition, using non-perishable materials which are not dangerous for the users of open spaces and must have a cubage of at least 5m<sup>3</sup>. Peano Foundation will contribute with the sum of 5,000 Euros towards the cost of

- realization of the artwork which will remain property of the Foundation itself. The economical contribute will be reimbursed to the artist upon receipt of proof of expense. Art. 10 The jury panel consists of the President of Peano Foundation or a delegated
- person, a representative of the Municipal Council of the Town of Cuneo, a representative of the District of Cuneo Downtown and two personalities of the art and culture system. The jury panel chooses the group of finalists which will then be voted by the
- Art. 11 The artists of the winning artworks, along with their tutors, will be informed in advance and invited to the prize-giving ceremony.

The exhibition will be opened on September 23rd, 2017 at 6.00 pm.

The winning sculpture of 20th International Sculpture Competition 2016 "The artwork and its urban context - Pio Brunone Lanteri Square in Cuneo"" will be unveiled on September 23<sup>rd</sup>, 2017 at 5.00 pm.
